Dear customers,

the school holidays in North Rhine-Westphalia are just around the corner –
from 27.06.2022 to 09.08.2022 it's holiday time.

In addition to the usual driving ban on Sundays and public holidays, there is a regulation in Germany to facilitate holiday travel by road. On all Saturdays beginning from 1 July to 31 August 2022 inclusive, certain stretches of motorways will not be free for trucks between 7.00 am and 8.00 pm.

In other European countries, similar driving bans have been imposed by the respective governments. There are various regional and country-specific driving bans there, some of which have a strong impact. In addition to the official driving bans, holiday habits, especially in Italy, Spain and Portugal, also influence the transport chain.

Delays and restrictions of the normal departure frequencies will also be unavoidable this summer, which will result in deviations from the regular transit time.

Please note that the standard cannot be maintained in every country, especially in week 32-34 in Southern Europe, due to the expected significant drop in order of volumes and the holiday periods in the individual receiving countries.

This means that deliveries and collections are, if at all, only possible to a limited extent or are associated with additional effort and costs.

For France, these above-mentioned restrictions already apply from week 29-33.

Our transport managers are always available to answer any questions you may have about transit times and express options.
