Summer departures 2024

Remscheid, 24th June 2024

Dear customers,

The school holidays are just around the corner - from 8 July to 20 August is holiday time and, as usual, transport volumes will be down across Europe.

In addition, there are also legal driving bans and company holidays at many of our consignees. Of course, we will do everything we can to get your goods to their destination in time. You can help us by checking - especially in August - whether your customer will accept your shipment.

If this is not the case, avoidable costs will be incurred - so please coordinate your scheduled deliveries with us individually. With this letter, we would like to inform you about restrictions that may affect your shipments. Please take this information into account when making your plans. In case of doubt, our road freight managers will of course be happy to help you at any time.

In addition to the legal ban on trucks driving on Sundays and public holidays, a regulation is in force in Germany to facilitate holiday traffic on the roads. On all Saturdays from 1 July to 31 August inclusive, certain highways sections and federal roads are closed for trucks from 7.00 am to 8.00 pm.

In other European countries, similar driving bans have been imposed by the respective governments. There are also various regional and country-specific driving bans, some of which are very noticeable. In addition to the official driving bans, holiday habits, especially in Italy, Spain and Portugal, also influence the transport chain.

Postponements and restrictions to the normal departure frequencies will also be unavoidable this summer, which will result in deviations from the standard transit times.

Also this year, mainly in week 32-35, please note that deliveries and collections in Southern Europe will only be possible to a limited level, if at all, or will involve additional effort and costs.

For France, these restrictions already apply from week 29-32.
